#### SUMMARY

The incumbent is responsible for repairs and installation of water and sewer mains; to run new water services; clean up from prior jobs; drive truck; haul parts and materials to jobs; may operate bulldozer and back hoe; and other duties when needed.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

- 1. Read meters, when needed.
- 2. Repairing water and sewer mains when needed.
- 3. Pour manholes and rehab them; test new manholes when installed.
- 4. Lay asphalt, pour concrete and apply top dirt, seed and fertilizer damaged areas.
- 5. Shoot grade on sewer lines when installed.
- 6. Assist mechanic with maintenance on equipment.
- 7. Operate back hoe and bull dozer when needed.
- 8. Perform other related duties as required or assigned.
